Drafts, notes, bills of exchange or orders for the payment of money may be endorsed by any of the signers in writing and deposited with Credit Union for the credit of said account. Endorsements may also be amid by stamp and without designation of the person endorsing.

“BE IT FURTHER BE RESOLVED, that said Credit Union is hereby authorized and directed to honor and pay and charge against the account any drafts, notes, bills of exchange or orders so drawn where such drafts, notes, bills of exchange or orders be payable to the order of any such person signing and/or countersigning such drafts, notes, bills of exchange or orders or to any such persons in their individual capacities or not and whether such drafts, notes, bills of exchange or orders are deposited to the individual credit or the person herein authorized to sign or countersign such drafts, notes, bills of exchange or orders or to the individual credit of any of the other officers or not.”

“BE IT FURTHER BE RESOLVED, that FRSA Credit Union is authorized to receive deposits and conduct said account in accordance with the agreement stated above and stated on the authorized signature card instruments and writings filed by the Credit Union.”

“BE IT FURTHER BE RESOLVED, that this resolution shall remain irrevocable as far as the Credit Union is concerned until said Credit Union receives in writing a copy of a resolution duly executed by the proper officers of this corporation setting forth instructions to the contrary.”
